P/F BankNordik as systemically important financial institution in the Faroe Islands

Pursuant to paragraph 308 of the Financial Business Act,¹ the Danish Financial Supervisory Authority on a yearly basis examines whether institutions designated as systemically important financial institutions (SIFI) in the Faroe Islands still exceed the threshold values regarding one or several of the below stated indicators for being designated as a SIFI institution in the Faroe Islands.

Pursuant to paragraph 308, section 4 of the Financial Business Act a condition for a systemically important financial institution (SIFI) for no longer being designated as a systemically important financial institution is that the institution for a period of three successive years has values regarding the below stated indicators which are lower than the assessed threshold values.

The Danish Financial Supervisory Authority has stated that BankNordik's values regarding the below mentioned indicators still exceeds the threshold values.

P/F BankNordik must meet a capital requirement in the form of a SIFI buffer requirement amounting to 2 pct. reflecting the institution's systemic importance on the Faroe Islands, see section 2(3) of Decree no. 693 of 22 May 2015. The SIFI buffer requirement must be met with CET1 capital. The requirement will be phased in during the period 2016-2019.

The Danish Minister for Industry, Business and Financial Affairs determines the SIFI buffer requirements within the framework of the systemic buffer, see section 125h, cf. 125a(6), of the Financial Business Act.
