Commissioned research: Føroya Banki – Q1 2025 first impression

Marketing material commissioned by Føroya Banki

Q1 profit before loan losses came in at DKK 56m, DKK 3m (6%) above our estimate. This was mainly due to net insurance income being DKK 3m (22%) above our estimate, driven by higher premium income and lower claims in Q1. Net interest income and net commission income were in line with our estimates, while other operating income was DKK 2m (24%) above our estimate due to extraordinary value adjustments. Costs were DKK 3m (4%) higher than our estimate, owing to a general increase in IT prices and staff costs. Loan losses in Q1 amounted to DKK 5m, DKK 5m worse than our estimate but mainly attributed to a few corporate clients. We also note that the management buffer remains unchanged at DKK ~100m. We hence continue to find Føroya Banki's asset quality solid. Finally, the CET1 ratio was 23.5%, 10bp below our estimate. The 2025 net profit guidance of DKK 210-240m was reiterated once more. We estimate DKK 221m. Given the miss on costs, we could see the share underperform peers slightly today.

Quarterly highlights

- Net interest income was DKK 76m, in line with our estimate.
- Net fee and commission income came in at DKK 18m, in line with our estimate.
- Net insurance income was DKK 16m, DKK 3m (22%) above our estimate. This was driven by higher premium income and lower claims in Q1.
- Costs were DKK 69m, DKK 3m above our estimate showing y/y growth of ~6.4%. This was attributed to a general increase in IT prices and staff costs.
- The bank reported loan losses of DKK 5m during Q1, DKK 5m worse than our estimate.
- The CET1 ratio was 23.5%, 10bp below our estimate.

Fair value and sensitivity

We calculate our fair values by weighting DCF, DDM, SOTP, asset-based and other standard valuation methods. Our fair values are sensitive to changes in valuation assumptions, of which growth, margins, tax rates, working capital ratios, investment-to-sales ratios and cost of capital are typically the most sensitive.

It should be noted that our fair values would change by a disproportionate factor if changes are made to any or all valuation assumptions, owing to the non-linear nature of the standard valuation models applied (mentioned above). As a consequence of the standard valuation models we apply, changes of 1-2 percentage points in any single valuation assumption can change the derived fair value by as much as 30% or more.
